It applies the Neo-Kadeshean Model of analysis and offers a framework for a 'Law on Power-sharing.' In a field dominated by political scientists, and drawing from ancient and contemporary international law, this book represents the first substantive legal critique of the law, practice, and politics of power sharing.
