Im abschließenden vierten Teil werden die wirtschaftswissenschaftliche und die politikwissenschaftliche Perspektive zusammengeführt. Die Beiträge präsentieren ein Modell der Bestimmungsfaktoren des unternehmerischen Corporate Governance-Verhaltens, das sowohl wirtschaftliche als auch politische Aspekte einbezieht. Die Autoren sind Wissenschaftler, die in Deutschland, Russland und Polen an renommierten Forschungsinstituten und Universitäten arbeiten. Sie sind ausgewiesene Experten zum Thema, die in ihren Beiträgen auf Ergebnisse langjähriger Forschungsprojekte zurückgreifen.
